IN THE SPOTLIGHT: SHERRY FOSTER TAXMAN

After marrying husband #1 in 1971, she moved to Omaha, Nebraska where she completed her degree at the mid-sized, coed, Jesuit Creighton University. One of her first post-college jobs was working at Project Success, a unique program for developmentally disabled adults, in a vocational/rehabilitation setting where she helped find employers who agreed to create jobs for her clients. During the past 40-plus years, Sherry has been asked to develop critical illness and qualified long term care plans for a consortium of companies. She also created software and payroll deduction plans for her clients.

For the past 25 years, Sherry has volunteered her time and efforts on the Boards of the Omaha Symphony Guild, Omaha Habitat for Humanity, Omaha Community Playhouse, Tuesday Musical Concert Series, Joslyn Art Museum, Beth Israel Synagogue and Omaha Opera. She is currently involved with the Joslyn Art Museum and Opera/Omaha.

FINCH WELCOMES FALL WITH A VISIT TO THE MUSEUM OF THE CITY OF NEW YORK

On Friday, September 23rd, seven Finch graduates and one "Friend of Finch" enjoyed touring a portion of the Museum of the City of New York's permanent exhibit "New York at Its Core: World City 1898-2012," the complementary half to "Port City: 1609-1898." The visit was led by docent and Arizona native, Kit Hermanson, a Ph.D. candidate at Columbia University, who, in an engaging manner, helped further our knowledge of New York City by interpreting the rise of Manhattan to a superpower through industrialization, finance, immigration, the arts, housing, civil rights, and politics.




